College Activity

HCA Oversight Committee

At our last Committee meeting, the College met with Michael Derbert, Chair of the HCA oversight committee. This group represents HCAs employed in Home Support as well as Aged Care Facilities and Hospitals. This group approached the College after our last newsletter, seeing how we might be able to connect, and help. One of the consideration raised by this group was that there are not clear definitions of exactly the HCA role.

Aged Safe Campaign

Discussions are underway to utilize the Case Mix system, which is used in Australia, and based on InterRAI, which has resulted in some RN/EN care minutes overseas. The system in New Zealand is different, and in distress—due to factors such as individuals not being able to sell their house as fast anymore, and many providers with financial pressures. Bridget is involved with the first Aged Safe Oversight Meeting—and will feedback at the next committee meeting.

NZNO College & Sections Day

Bridget and Aloha attended the annual College and Section Day earlier this year, where Aloha presented from the College. Anne Daniels, President presented around that nursing is about the whole, not just tasks.

The Women's Health College is providing training to upskill their RNs.

The Pacific Nurses College are exploring Pathways to Registration—consultation ahead with Nursing Council around this.

The Nursing Research section is completing a twice yearly journal, and support individuals with their research.

The EN Section presented, and reiterated the message around not forgetting ENs and the role they play. 200 hours have now been removed from their training, now 700 are required.

Rob Zorn (NZNO Media & Communications) wants to increase the profile of Colleges and Sections and individual colleges can approach him for help as needed.

Knowledge & Skills Framework

Knowledge and Skills Framework
At our last Committee meeting, we met with a technical writer who will be providing us some assistance with finalizing the Gerontology Knowledge and Skills Framework. The Committee has contracted out this service, and we hope to be able to share a finalised KSF in the coming months.

College Submission—HDC Code and Act Review

The College has prepared a submission as part of the HDC Act and Code Review consultation. The key aspects of feedback HDC asked as part of this consultation included:

- Supporting better and equitable complaint resolution
- Making the Act and the Code more effective for, and responsive to the needs of Maori
- Making the Act and Code work better for disabled people
- Considering options for a right of appeal to HDC decisions
- Minor and technical improvements

The College considered this document, and shared the following feedback as part of the consultation process:

- Importance of encouraging complainants to engage with the provider in the first instance,
- In terms of supporting better complaint resolution, the College agreed with the proposed changes around broadening purpose statement and including ‘upholding mana’, more inclusive language and feedback around the term ‘no investigative action’, as this felt it could be misleading
- The College agreed that Tikana should be included in the Code, as well as practical effects from the Treaty
- The College agreed that there should be a right of appeal for consumers and healthcare providers, and when a review is undertaken, it should be an independent review.
- Concerns expressed by the College around advancing technology were also shared.

Nurse Maude Assessment Centre

In May, Marg (Professional Nursing Advisor) attended the official opening of the Nurse Maude Simulation and Assessment Centre held at the Nurse Maude complex in Christchurch.

The Centre is part of Te Kaunihera Tapahi o Aotearoa - Nursing Council of New Zealand's new model for assessing the competence of Internationally Qualified Nurses (IQNs) seeking registration to work in NZ.

The new process requires applicants to undertake an orientation and preparation course (OPC) and objective structured clinical examinations (OCSEs) in Christchurch. It replaces the Competency Assessment Programme (CAP) course that has been used until now.

The official opening was led by representatives from Tuahiwi Marae, in conjunction with Nurse Maude leaders. The opening honoured the contributions of many whose input had led to the development of the new facility. Those contributions included Nursing Council; Nurse Maude who were the successful bidders to run the national facility; University of Canterbury who are partners and facilitate the 2-day orientation and preparation course; the contractors who designed and refurbished the existing building to fulfil its new purpose; and the members of the new team who will run the OSCEs. The ceremony was attended by local nursing leaders of health services that newly registered nurses will seek positions at, and other stakeholders in nursing workforce development.

After the official blessing, there was an opportunity to visit the assessment centre and to see the rooms where 'patients' will be assessed to demonstrate clinical knowledge and skills in practice. There are ten rooms – one for each scenario. Each candidate completes all ten scenarios. Candidates are given 2 minutes to read the scenario before entering the room and 8 minutes to complete it once in the room.

The OPC and OSCE process represents a new way for some IQNs required to demonstrate their competence for registration as a nurse in New Zealand.

Nurses in Policy—Webinar Feedback (Marg Bigsby, PNA)

I recently attended a series of four one-hour webinars as part of a Nurses in Policy course that was promoted by the College of Nurses Aotearoa, and led by two facilitators from NZIER. The workshops were themed as follows:

1. The machinery of government and policy process – facilitated by Todd Kriebler
2. Policy tools and options – facilitated by Sarah Hogan
3. Cabinet briefings and the art and craft of advising – facilitated by Sarah Hogan
4. Working with Crown entities and course consolidation – facilitated by Todd Kriebler

Todd Kriebler is a deputy director of NZIER. Sarah Hogan is Principal Economist with NZIER. Both presenters have extensive experience in a range of leadership roles in Ministry of Health and health governance, both nationally and overseas. They tailored the presentation content to contexts relevant to nurses.

There were ~ 15 participants on the course who came from a range of nursing leadership roles, including 2 chairs of NZNO colleges. Learners sought to achieve the 3 objectives of the series:

1. Increase nurses' input to decision-making
2. Navigate the 'system'
3. Construct winning arguments

The structure of sessions included: information sharing of key ideas; discussion about specific questions in break out rooms and representatives feeding back to the whole group; reading sample documents; and reviewing "Master class" notes on relevant topics.

The workshops were useful in increasing my understanding of factors that contribute to exerting influence over decision-making. Working as a NZNO Professional Nursing Advisor, I participate in consultation opportunities (for example, the current Health and Disability Commission Act and Code Review, and the Future of Aged Care Funding and Service Delivery Models Engagement Survey). I support College committees to engage in numerous consultation opportunities relevant to their clinical contexts. PNAs participate in working groups of NZNO staff, for example the College and Section Lifting Influence and Reach Project, and support the work of groups of member representatives, for example NZNO's Age Safe National Oversight group, or where members are faced with a proposal for change in the nature of their clinical work. Even working with individual members provides the opportunity to create a case to influence the decision-making.

I found this professional development to be valuable and recommend it to other nurses seeking to strengthen their knowledge and skills in decision-making. The resources and strategies presented support influencing decision-making at highest levels of government, however they are also broadly applicable to any setting that nurses work in. The workshops are offered once or twice/year
